Pharmacy Guidelines:

Patients that fall under the 100% of FPG will pay the prevailing rate for prescriptions with a maximum of \$1.00 per prescriptions.

Patients that fall in the 100% to 200% categories with discounts of 20 %, 30%, 40%, 60%, 80% (see chart above) will pay the prevailing rate less the appropriate discounts as specified in the above chart.
